Cllr Wills welcomed everyone and explained the reason for calling this extraordinary meeting

20/98 To accept apologies for absence.

20/99 Declaration of interest in items on the agenda.

Cllr R Bainbridge declared in interest on items on the agenda related to contracts for work at the Bowling Club and will not take part in any decision made for that item.

20/100 To confirm the minutes of the last meeting on 28th July 2020

20/201 PUBLIC FORUM & MEMBERS COMMENTS– (this will be limited and at the Chairs discretion)

It was noted that the safety signs at the skate park have been covered with graffiti paint so more will be ordered and fixed in a different location to avoid them being covered again. The chair informed the meeting about the plans for the new memorial bench which will be fitted near the skate park.

20/202 To consider the grant application from IPFARA

The Chairman introduced this item and explained the request. *(Standing Orders were suspended)* Mr Hobbs gave more details of what the Bowling club hoped to achieve to increase security following the recent theft of a piece of the carpet. Location of CCTV cameras and extra lighting and how that is managed were discussed, the cost would be approx. £1500. Then the requirement of new fencing was discussed, and *(Cllr Bainbridge withdrew from this part of the meeting)*. The cost for this is in the region of £1300.

The councillors noted that signage would be needed when installing CCTV.

Initially it was proposed a grant of £3000, then after further consideration Cllr Reeve suggested the grant should be for £3500, this was seconded by Cllr Prior and all were in favour.
