Ilsington Parish Council Meeting, Tuesday the 22^{nd of} July 2025

MINUTES OF THE MEETING

Cllr Reeve welcomed everyone to the meeting.

25/101. To accept apologies for absence.

None received this evening

25/102. Declaration of interest in items on the agenda.

25/103. PUBLIC FORUM & MEMBERS COMMENTS – (limited to 10 minutes)

- Applicants with planning applications for consideration may also speak for up to 3minutes on behalf of their own application
- During the Public Open Forum: Members of the public should note that the council is only allowed to take decisions on topics that are publicised on the agenda; items not on the agenda can be carried forward for a response at a later date.
- After the Public Open Forum: Members of the public are asked to respect the fact that it is a meeting to conduct council business and participation during the remainder of the meeting is not permitted without the express consent of the Chairman.
 - Member of the public raised concerns over speeding vehicles on Old Liverton Road especially at the Exeter Cross and Oakleigh Park area, he noted that there are approximately 200 residents in that particular area. He is also concerned that there are not many streetlights in the same area. Cllr Freeman asked if the matter of streetlights have been discussed in the past, Cllr Wills confirmed it has. Cllr Reeve explained that the Parish Council required permission from DCC regarding the location and type of monitor which has now been fitted. Cllr Freeman wondered it a larger 30mph at the entrance of Old Liverton Road would improve matters, these suggestions would need to be sent to the parishes Highways Engineer.

Cllr Mike Freeman asked about the A3828 upgrade and asked for this to be an agenda for the September meeting; due to the disruptions and impact it will cause in this parish.

He asked if a representative of the project team can attend our meeting to address some of our concerns. Cllr Morgan explained and acknowledged there would be 12 months of disruption but without the closure of the road the work would take 2/3 years to complete. Cllr Morgan will liaise with the team and request a representative to attend the September meeting.

ACTION: Cllr Morgan contact A382 team to ask a representative to attend our September meeting

25/104. To receive reports from District, County Councillors, DNPA Ranger, Lengthsman and Police.

<u>Cllr S Morgan – DDC Cllr Morgan</u> is also concerned about the work to the A3828 road, she asked to be included on the email regarding a 30mph sign at Liverton.

While DCC are still aware of the need to repair the potholes and road surfaces their priority is SEN and due to lack of funding the council are working hard to address the huge deficit and future targets and reorganisation take up a lot of time, she has made good connections with the officers and has a positive outlook for the areas she covers.

Cllr Wills asked if she supported Devon villages getting 20mph limits, yes, she does but 20mph zones involves physical construction with a capital cost, using signage is cheaper way to try to achieve reducing the speed of vehicles.

Cllr R Steemson TDC – following the last meeting Cllr Steemson has made the enquiries regarding Little Liverton Park and the reply from the planning office has been circulated prior to this meeting. The permission related to the new development of 1300 houses at Houghton Barton will include a school, a surgery and 28 local needs housing will be starting in Autumn. In the news this evening it was reported that 100 houses will be built a year. Cllr Steemson noted that as improvement to Drumbridges will not be imminent there should be at least improvements to the road surface in the meantime. Finally the council will be considering the closure of public toilets within the region at their next full meeting.

DNPA – Our sector ranger will be taking a sabbatical for a year it is not sure who will be covering the area for that time. Cllr Steenson will however be helping with the plans to put boulders and barriers in place to prevent the fly tipping on Rams horn Down.

Paul Wilson (PCSO 30382) Chudleigh Police Office, Ashburton& Chudleigh Neighbourhood Police Team - report that in the period 1st June 2025 to 19th July 2025 (when report was compiled) there were approximately 11 recorded offences across the Parish area. The offences are shown below.

Assaults; 2 Blackmail; 1 Harassment offences; 2 Public order; 1 Theft; 4 Threat to damage/destroy; 1

There were approximately 21other incidents reported to the Police in this period, these include road traffic incidents, concerns for welfare, and anti-social behaviour.

The councilors are not happy to remove their objection, as using the slip road as a one-way system to serve the business park would be a much better solution. The explanation about turning left still is not supported as much safer to turn at the lower junction as it is away from the bend in the road.

Cllr Reeve proposed the council should go ahead and purchase it after asking if the software has a time limit, it does but Cllr Turner reassured the meeting it would be enough for the purpose of the project.
