6. Planning Informal Hearing Advice Date - Land Opposite Chapel Lane, Liverton Road Newton Abbot Devon TQ12 6YY - to appoint a councillor to represent this Parish council at the hearing on Thursday 19th March 2020 at TDC

Cllr M Wills volunteered to attend as the Councils represented giving the councils comments as followed - There is a further 'material consideration' the road slopes significantly downwards to the site entrance from Cummings Cross means that stopping distances will be significantly longer for traffic approaching from that direction especially for heavier vehicles and for all vehicles in wet weather (which is the default for our parish) - meaning that the visibility splay required for a safe entrance/exit to the site would need to be much longer than has previously been assessed (and not been achievable) for a level site. In sum: It has already been shown that safe visibility splays cannot be achieved for this site - this slope means that this fact is beyond doubt. Also since this application has been lodged the need for the provision has changed. Three planning applications for gypsy/traveller sites have been submitted and some granted give potentially 30 extra pitches within this local area. Finally local feeling for this development in this location is not supported by the local community giving that at the council meeting where this application was on the agenda
